Beneficiaries shall submit Detailed Project Report (DPR) with justification including demand and supply gap in the project locality, detailed cost estimate, technical specifications of the components of feed mill/plant, recurring cost involved, source of funds for meeting the beneficiary share including bank consent wherever applicable, undertaking of beneficiary to the effect that no other governmental assistance is availed for the proposed project, anticipated direct & indirect employment generation to local population, and specific time lines for completion of the project etc.
2. Beneficiaries shall provide documentary evidence of availability of requisite land (either own/registered lease), necessary clearances/permissions from the concerned authority as may be required.
3. The Beneficiaries shall submit an undertaking in the DPR to the effect that all operational, maintenance and post construction management costs of the infrastructure facilities shall be borne by him and feed mill be kept in operational condition.
