Fisheries Order No. 376 of 2012

While discussion, the future planning of the Department and in view of urgent requirement of meeting the pressures of privatization of fisheries in the state, it is resolved that initially extraordinary inputs should be given for the existing infrastructure, for consideration, for option utilization, which would enable the Department to immediately increase the present status of production and performance by 20% more.

In order to assess the strengthening / repairs of to be conducted in the units of Kashmir Division, it is resolved to constitute two regional Committees in Kashmir Province to furnish the proposal for consideration of Central Level Technical Committee headed by Director Fisheries so that next year works programmes provide scope for consideration of items on priority.

Mandate:-

1. Judicious use of assets, measures for upgradation. Further
2. Priority in case of maintenance of assets viz offices/hatcheries Farms etc.
3. Proper planning of resources and their potential use.
4. Selection of sites for Farm/Hatchery/Construction of Ponds Trout/Carp.
5. Selection procedures in different welfare schemes.
6. Measure regarding Research and Developments.
