**NOTICE**

**Sub: - Issuance of Permits for the Trout Angling during the year 2019-20.**

With the commencement of the Trout angling Season, booking of Trout Fishing Permits through online mode shall resume **w.e.f. 1<sup>st</sup> April, 2019.**

The following information/instructions are brought to the notice of all concerned for implementation/enforcement in letter and spirit.

01. The Trout Permits for angling in various trout streams of the State will commence from 1<sup>st</sup> week of April, 2019.
02. The permits will be issued through online mode and the app has been posted/ annexed at [jk.gov.in/jkeservices](http://jk.gov.in/jkeservices) portal . However the hyper link will be also available on the Fisheries Department Website [www.jkfisheries.in](http://www.jkfisheries.in). **The link will be activated on 01-04-2019.**
03. The trout fishing permits will be available for esteemed Foreign Anglers throughout the week including Saturday and Sunday. For the local citizens it will be available on permitted days only i.e. Saturday, Sunday (02 days a week).
04. The trout beats for fishing will be allotted on first come first serve basis. Few beats shall remain reserved/ restricted for conservation purposes.
05. The esteemed anglers are requested to co-operate with the Department for ensuing judicious trout angling in all the streams and book the permits as per the availability.
06. The esteemed anglers are requested not to rely upon any unauthorized person/persons posing themselves as agents for the issue of permits from the Department as they may give wrong information/advice.
07. This arrangement shall be subject to review/modification/cancelation, depending upon the condition of the trout streams and angling report.
08. As a conservation measure in the month of April and May, beats existing in lower belts should be preferred by the esteemed angler's


  


because of high current of water. Subsequently beats in higher reaches are suitable for good fishing as soon as water level starts stabilizing.

09. The permits issued shall be non transferrable and non refundable.

Esteemed Anglers are requested to co-operate for strengthening of long prosperous world class Trout Angling in Kashmir in particular and in the State of J&K in general.

Wishing all the esteemed anglers good and thrilling fishing in forthcoming fishing season.
