- Note 1. Bid document shall be issued to Domicile of Union Territory of Jammu and Kashmir only the persons registered with Municipal Corporations, Municipal Committees, Panchayats dealing with fish trade exclusively shall be eligible to participate in the eauction (now Union Territory of Jammu & Kashmir) on production of valid Domicile Certificate from the competent authority.
- Note 2. The Bidders are required to go through the terms and conditions minutely and clear any doubt before submitting their Bid. The Bidder shall sign each page of this document in token of acceptance of the terms and conditions mentioned herein and submit the same along with the Bid offer.

I. General instructions/terms and conditions:

The Bid shall be uploaded from the official website (www.jktenders.gov.in) and submit the following documents:-

- a. Earnest Money Deposit for an amount of Rs. 25000/- (Rupees twenty five thousand) for Retail outlet in the shape of Demand Draft favouring to the Chief Project Officer Marketing Division Jammu.
- b. Attested Copy of Domicile Certificate duly issued by the competent authority.
- c. Bid document dully signed.
- d. DD for an amount of Rs. 1000/- (Rupees One Thousand Only) pledged to Chief Project Officer Marketing Division Jammu.

II. Second Bid shall contain Financial Bid.

The Bid document shall be downloaded from 26.08.2021against payment of Rs. 1000/-(Non-Refundable) in the shape of Demand Draft pledged to Chief Project Officer Marketing Division Jammu and shall be uploaded from official website (www.jktenders.gov.in) up to 08.09.2021 upto 4.00 PM. However no hard copy for financial bid is required. The Bid shall be opened on 10.09.2021 at 1.00 PM or any other date which shall be notified on departmental notice board convenient to opening authority in presence of Bidders who may like to be present. However if the Bid opening day happens to be a holiday or office remains closed due to any other reason, then Bid shall be opened on next working day. Direct or indirect canvassing on the part of Bidders or their representatives shall render his/her Bid as disqualified.

Terms and conditions:-

- 1. Minimum reserve bid for retail outlets shall be Rs. 6.10 lakh per out let.
- 2. Persons registered with Municipal Corporations, Municipal committees, Panchyats dealing with fish trade exclusively shall be eligible to participate in the e auctioning.
- 3. Only permanent residents above Eighteen years of age shall be eligible to participate in the e-auctioning and have to attach proof of residence.
- 4. In case of tie between two or more bidders allotment shall be made through draw of lots.
- 5. Each bid must be accompanied with an earnest money of Rs. 25000/- (Rupees Twenty Five Thousand only) per retail outlet in the shape of demand draft pledged to the Chief Project Officer Fisheries, Fish Marketing Division, Jammu.
- 6. Priority will be given to retail sellers who are working and identified by Jammu Municipal Corporation operating within the boundary of Jammu Municipal Corporation. But allotment will be made only provided that their bid is higher than the Reserve bid and are able to match the higher bid submitted by any other person.
- 7. The Cleanliness of the Fisheries Market Complex will be carried out by Jammu Municipal Corporation by charging on the retailers appropriately from time to time.
- 8. The successful bidders/ allottee will have to enter an agreement with the Department of Fisheries to ensure that if there is any violation in terms of Sale of any commodities other than the fish found will be deemed to be Cancelled immediately and retail outlet will be put on e-auction again.
- 9. The Successful bidders shall have to deposit 25% of the premium within thirty days from the date of issue of letter of intent and balance payment shall have to be made in three quarters in equal instalments starting from the due date of first instalment.
- 10. The earnest money shall be adjusted towards the last installment and in case of failure in Payment of first installment, the allotment shall be cancelled with forfeiting of earnest money.
- 11. A grace period of maximum three months can be allowed for payment of subsequent three installments subject to the payment penalty @18% per annum of the balanced amount. If the default goes beyond the grace period, the cancellation of allotment and forfeiting of earnest money shall be the sole discretion of Director Fisheries Govt. of J&K.
- 12. In case the bid amount is less than the reserve price the earnest money deposited will be forfeited.
- 13. The allotee shall execute lease deed duly attested by First Class Judicial Magistrate with the department of fisheries through authorized officer of the department for a period of Twenty years to begin with and renewable thereafter. Cost of stamp duty, Registration Fee of lease deed and any other incidental charges whatsoever levied by the Govt./ Local bodies/ Department of Fisheries / JDA shall have to be paid by the leasee.

14. The successful bidder shall have to abide by the rules/ regulations and other terms & conditions of the department laid down from time to time and in terms of J&K Fisheries Act.
