Sanction is hereby accorded to the withdrawal of Input Cost for 02 No. new Carp Ponds under General category from ADF Shopian alongwith the funds to the tune of Rs 0.161 lacs from the concerned DDOs released as Central Share for the purpose for implementation of the approved action plan of 2017-18 approved by GoI under Central Sector Scheme Blue Revolution - Integrated Dev. & Management of Fisheries the funds of which were revalidated/ released by Administrative Department/ by this office vide Government Order/Fishries Order mentioned above for utilization during 2018-19.

Consequent upon the above, sanction is also hereby accorded to the release of Input Cost for additional 02 units of New Carp Ponds under General Category as Central Share to the tune of Rs 0.161 lacs (Rupees Sixteen Thousand & One Hundred only) under the Central Sector Scheme "Blue Revolution"-Integrated Development & Management of Fisheries and placement of the same in favour of ADF Pulwama for utilization during 2018-19. The scheme should be implemented strictly as per norms & guidelines of the Ministry of Agriculture and Farmers Welfare, Department of Animal Husbandry, Dairying & Fisheries and instructions issued by the State Government from time to time. The latest instruction conveyed vide No. DF/Plng/2018/CJ/6314-67 Dated 15-02-2018 in this regard should also be adhered to strictly. The concerned Joint Directors shall monitor the implementation of the scheme on weekly basis.
