
**ORDER No. 268 of 2019**

Sanction is hereby accorded to the withdrawal of one unit of Auto-Rikshaw with Ice- Box under General category from Assistant Director Fisheries Poonch alongwith funds amounting to **Rs.0.72 lacs (Rupees seventy two thousand only)** released as Central Share under CSS- Blue Revolution during the year 2018-19 (against the revalidation of approved plan of the year 2017-18) and the unit so withdrawn is allotted to Assistant Director Fisheries Anantnag alongwith release of funds to the tune of **Rs. 0.72 lacs** under the said scheme/head "Auto-Rikshaw with Ice box" for utilization during 2018-19. The scheme should be implemented strictly as per norms & guidelines of the Ministry of Agriculture and Farmers Welfare, Department of Animal Husbandry, Dairying & Fisheries and instructions issued by the State Government from time to time. The concerned Joint Directors shall monitor the implementation of the scheme on weekly basis. The details are given as below.

- c Expenditure be incurred on the object for which sanctioned and no diversion or re-appropriation be made from one scheme to another without the concurrence of Competent Authority.
- d Monthly/quarterly progress reports indicating physical/financial achievements should be submitted to this office by or before 5th day of every next month/quarter positively.
- e Release of funds in no case is an authority to draw the payments from the treasury unless & until DDO vis fully satisfied about the genuinity of claim.
- f No deviation in specification shall be entitled for payment except those approved by the competent authority.
- g The account officer shall vouchsafe the utilization of funds as per codal formalities /GOI guidelines
- h The expenditure shall be booked strictly on the approved components of the scheme
- i Joint Director Territorial Jammu/Kashmir will furnish the soft/hard copy of the consolidated list of beneficiaries selected for providing assistance .
- j The revised pattern of Assistance for General category is 36:4:60 (Centre:State:Beneficiary) & for Scheduled caste category is 54:6:40(Centre:State;Benificiary)
