Sanction is hereby accorded under **Rule 12(1) of G.P Fund (Central Services) Rules, 1960 read with office Memorandum No: 03/2/2017-P&PW(F)(i) dated: 07-03-2017** to the grant of Refundable G. P. Fund advance of ₹ **10,33,000/- (Rupees ten lac thirty three thousand only)** in favour of **Sh. Showkat Ahmad Bhat** designated as **Assistant Director Fisheries** out of his G.P. Fund computer code **750106302** to enable him to defray the expenses in connection with **Purchase of consumer durables.**

A sum of ₹ **5,61,717/-** out of aggregating amount of ₹ **12,55,000/-** sanctioned in **01/2020** is still outstanding against the subscriber. Fresh advance of ₹ **10,33,000/-** together with previous balance of ₹ **5,61,717/-** aggregating to ₹ **15,94,717/- (Rupees fifteen lac ninety four thousand seven hundred and seventeen only)** shall be recovered in **60** equal monthly instalments of **Rs 27000/-** and last being of **Rs 1717/-** Commencing from the salary of the month following the month of drawal of the advance.

The official is not likely to retire before the liquidation of advance in full as the date of birth of the official is **10-03-1970** and the advance is within 75% of available balance so computed.
