A sum of ₹ **1,58,903/-** out of aggregating amount of ₹ **2,37,104/-** sanctioned in **11/2022** is still outstanding against the subscriber. Fresh advance of ₹ **1,50,000/-** together with previous balance of ₹ **1,58,903/-** aggregating to ₹ **3,08,903/- (Rupees three lac eight thousand nine hundred and three only)** shall be recovered in **60** equal monthly instalments of **Rs 5200/-** and last being of **Rs 2103/-** Commencing from the salary of the month following the month of drawal of the advance.

The official is not likely to retire before the liquidation of advance in full as the date of birth of the official is **25-04-1976** and the advance is within 75% of available balance so computed.
