The mandate of these committees is as under:

- The committee will recommend the layout, projects requirements etc. of all the approved projects to be taken under NABARD and other schemes in consultation with the concerned District Officers / Project Officers. The District Officers shall get the DPR's framed by the executing agencies as per the recommendations of the respective committees.
- Expansion and exploring the areas to be covered under Pisciculture, besides ascertaining the feasibility for site selection of Mega Projects in consultation with the concerned District Officers/ Project Officers.
- Evaluate suitable mechanism for introduction of new economically viable exotic / endemic culturable and ornamental species of fishes in the UT of J&K visa viz their impact on the environment.
- Suggest innovative measures for up-gradation of the existing departmental projects / units in consultation with the concerned District Officers/ Project Officers.
- The Committee will explore the scope for rearing prawn/jhinga on trial basis in Jammu Division and shall formulate DPR with requite SOPs in this regard.
- Explore the possibilities to facilitate market linkages between trout Farmers and develop modus operandi for creating marketing channels for Trout in both domestic and International Markets
- 7. The committee in close coordination with the respective District Officers shall scrutinize and monitor the progress/ functioning of various Fisheries Projects being executed under NHPC. The committee will suggest measures to remove bottle neck and loop holes if any and will ensure the judicious use of the funds and the timely completion of the projects.
- Both the Divisional level committees will work in tandem to address all the technical matters for holistic Development of Fisheries in UT of J&K.
- The Deputy Director Planning & Accounts officer of this Directorate will coordinate and provide all requisite details viz; status and availability of funds, etc.

The concerned District Officer / Project Officers shall act as Member Secretary for the respective Divisional Level Committee and will facilitate the committee during their visit to the respective Districts /Projects.
