Sanction is hereby accorded under Rule 12(2) of G.P Fund (Central Services) Rules, 1960 read with office Memorandum No: 03/2/2017-P&PW(F)(i) dated: 07-03-2017 to the grant of Refundable G. P. Fund advance of ₹ 4,95,000/- (Rupees four lac ninety five thousand only) in favour of Shri Mehraj-ud-din wani designated as Senior Assistant out of his G.P. Fund computer code 790014455 to enable him to defray the expenses in connection with education of daughter.

A sum of ₹ 4,36,796/- out of aggregating amount of ₹ 6,94,796/- sanctioned in 03/2023 is still outstanding against the subscriber. Fresh advance of ₹ 4,95,000/- together with previous balance of ₹ 4,36,796/- aggregating to ₹ 9,31,796/- (Rupees nine lac thirty one thousand seven hundred and ninety six only) shall be recovered in 60 equal monthly instalments of Rs 15700/- and last being of Rs 5496/- Commencing from the salary of the month following the month of drawal of the advance.

The official is not likely to retire before the liquidation of advance in full as the date of birth of the official is 12-03-1973 and the advance is within 75% of available balance so computed.
