1. The DDO shall draw arrears strictly in terms of rule 295 GFR 2017 and instructions issued by the Finance Department vide Circular No. A/23(8)-1-B 184 dated, 18.02.2021.
2. That the DDO concerned shall allow the benefit of In-situ promotion in respect of the above mentioned retired official only after satisfying himself about;

- (a) The eligibility of the retired official for the same.
- (b) That the said retired official was not under suspension or is being contemplated to be charge sheeted under Classification Control and Appeal Rules 1956 or any other rule/law
- (c) That his work and behavior has remained satisfactory.
- (d) That the present In-situ promotion shall not change/effect the existing designation/ seniority/duty.
- (e) That the benefit of HSPS shall not be given to such of the employee/s who had relinquished/forgone the functional promotion for any reason, whatsoever.
