The appointees shall report to their place of posting as indicated above within a period of Twenty-One (21) days from the date of issuance of this order failing which their appointment shall be deemed to have been cancelled ab-initio without any further notice.

The appointees shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:

- i. Academic/Qualification Certificates.
- ii. Matriculation / Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate issued by the Competent Authority
- v. Valid relevant Category Certificate, if any, applicable

The appointment of the above mentioned candidates shall further be subject to the following conditions:

- a) The appointees shall submit an undertaking in the shape of an affidavit to the effect that if on verification, their Qualification/ Date of Birth/ Reserved Category Certificates from the concerned issuing authorities are found fake/forged, their appointment as Deputy Inspectors Fisheries/equivalent in the Fisheries Department, J&K shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against them.
- b) That if the candidates have taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, they shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. They shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from their salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- c) That the salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of their Qualification/Date of Birth/Relevant Category Certificate is received from the concerned Authorities/Agencies.
- d) That the appointees shall be on probation for a period of two years.
- e) That the appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.

- f) That the inter-se-seniority of the appointees shall be determined in accordance with merit secured by them in the selection list prepared by the J&K Service Selection Board and in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- g) The cadre allocated by Appointing Authority/SSB shall not be changed under any circumstances.
- h) That the appointment of the above mentioned appointees shall be subject to the outcome of writ petition(s), if any, pending before Competent Court of law.
