Whereas, the Administrative Department vide letter No. FISHONGAZ/26/2023-7343099 dated 04-12-2023 forwarded the selection list of 06 Candidates, framed by J&K Service Selection Board, for the post of Inspector Fisheries/Equivalent.

Whereas, only 05 selectees joined the Department and 01 selectee Sh. Irfan Ahmad under ST Category didn't join, consequently the post remained unfilled/vacant.

Whereas, the Administrative Department vide letter No. Agri-Grie/4/2024 (7567249) dated 17-09-2024 forwarded the waiting list in respect of Inspector Fisheries/equivalent, framed by J&K Service Selection Board for appointment under rules.

Whereas, the Verification report of character and antecedents of the official has been received on designated portal.

Therefore, on the recommendations of J&K Service Selection Board, and further endorsement of Administrative Department vide above reference, Sanction is hereby accorded to the appointment of below mentioned candidate as Inspector Fisheries/equivalent (UT cadre) in J&K Fisheries Department, in the Pay Level of L6E (35900-113500) with immediate effect.

The appointee shall report to the Office of Chief Project Officer National Fish Seed Farm (NFSF) Kathua within a period of Twenty-One (21) days from the date of issuance of this order failing which he shall forego his right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further Notice.

The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently;

- Academic/Qualification Certificates.
- Matriculation / Date of Birth Certificate.
- Health Certificate from the concerned Chief Medical Officer of the District.
- Domicile Certificate issued by the Competent Authority
- Valid relevant Category Certificate, if any, applicable.

The appointment of the above mentioned candidate shall further be subject to the following conditions:

- a) That the appointee shall submit an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/Date of Birth/Reserved Category Certificates from the concerned issuing authorities is found fake/forged, his appointment as Inspector Fisheries/equivalent in the Fisheries Department, J&K shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b) That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- c) That the salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of his Qualification/Date of Birth/Relevant Category Certificate is received from the concerned Authorities/Agencies.
- d) That the appointee shall be on probation for a period of two years.
- e) That the appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- f) The inter-se-seniority of the appointees under the above referred selection list shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- g) That the appointment of the above mentioned appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
