A sum of **₹ 4,40,387/-** out of aggregating amount of **₹ 6,24,936/-** sanctioned in **12/2023** is still outstanding against the subscriber. Fresh advance of **₹ 3,00,000/-** together with previous balance of **₹ 4,40,387/-** aggregating to **₹ 7,40,387/- (Rupees seven lac forty thousand three hundred and eighty seven only)** shall be recovered in **60** equal monthly instalments of **Rs 12400/-** and last being of **Rs 8787/-** Commencing from the salary of the month following the month of drawal of the advance.
