The appointees shall report to the Directorate of Fisheries, Jammu/Srinagar within a period of Twenty-One (21) days from the date of issuance of this order failing which they shall forego their right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further Notice.

The appointees shall be allowed to join only on the production of the following certificates (in original) to be got verified subsequently:

- vi. Academic/Qualification Certificates.
- vii. Matriculation / Date of Birth Certificate.
- viii. Health Certificate from the concerned Chief Medical Officer of the District.
- ix. Domicile Certificate issued by the Competent Authority
- x. Valid relevant Category Certificate, if any, applicable.

The appointment of the above candidates shall further be subject to the following conditions:

- h) Each appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his/her Qualification/Date of Birth/Reserved Category Certificates from the concerned issuing authorities is found fake/forged, his/her appointment as Deputy Inspector Fisheries/equivalent in the Fisheries Department, J&K shall be deemed to have been cancelled abinitio and the legal action as warranted under rules shall be initiated against him/her.
- i) That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DD0 concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

- j) The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate is received from the concerned Authorities/Agency.
- k) The appointees shall be on probation for a period of two years.
- The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- m) The inter-se-seniority of the appointees shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- n) The appointment of the above appointees shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
