A sum of **₹ 3,08,914/-** out of aggregating amount of **₹ 4,75,790/-** sanctioned in **03/2023** is still outstanding against the subscriber. Fresh advance of **₹ 2,50,000/-** together with previous balance of **₹ 3,08,914/-** aggregating to **₹ 5,58,914/- (Rupees five lac fifty eight thousand nine hundred & fourteen only)** shall be recovered in **60** equal monthly instalments of **Rs 9400/-** and last being of **Rs 4314/-** Commencing from the salary of the month following the month of drawal of the advance.
