Sanction is hereby accorded under Rule 12(2) of G.P Fund (Central Services) Rules, 1960 read with office Memorandum No: 03/2/2017-P&PW(F)(I) dated: 07-03-2017 to the grant of Refundable G.P Fund advance of ₹ 4,40,000/- (Rupees four lac forty thousand only) in favour of Shri Mohd Sikander Lone designated as Multitasking Staff out of his G.P Fund computer code 750124588 to enable him to defray the expenses in connection with Purchase of consumer durables.

A sum of ₹ 3,47,572/- out of aggregating amount of ₹ 6,54,300/- sanctioned in 11/2022 is still outstanding against the subscriber. Fresh advance of ₹ 4,40,000/- together with previous balance of ₹ 3,47,572/- aggregating to ₹ 7,87,572/- (Rupees seven lac eighty seven thousand five hundred & seventy two only) shall be recovered in 60 equal monthly instalments of Rs 13150/- and last being of Rs 11722/- Commencing from the salary of the month following the month of drawal of the advance.

The official is not likely to retire before the liquidation of advance in full as the date of birth of the official is 01-04-1975 and the advance is within 75% of available balance so computed.
