A sum of ₹ **6,37,262/-** out of aggregating amount of ₹ **7,90,662/-** sanctioned in **11/2023** is still outstanding against the subscriber. Fresh advance of ₹ **1,50,000/-** together with previous balance of ₹ **6,37,262/-** aggregating to ₹ **7,87,262/- (Rupees seven lac eighty seven thousand two hundred & sixty two only)** shall be recovered in **53** equal monthly instalments of **Rs 14854/-** and last being of **Rs Nil** Commencing from the salary of the month following the month of drawal of the advance.
