In partial modification to Fisheries order No. 237 Dated 21-12-2021 Sanction is hereby accorded to the withdrawal and reallocation of Low Cost Houses under General category. The funds under all the categories shall be withdrawn in accordance to the withdrawal and reallocation of units @ Rs. 1.17 lacs as Central Share under the Centrally Sponsored Scheme "PMMSY" revalidated funds 2021-22. The scheme should be implemented strictly as per norms & guidelines of the Ministry of Fisheries, Animal Husbandry & Dairying, Department of Fisheries and instructions issued by the J&K Government from time to time. The concerned Joint Directors shall monitor the implementation of the scheme on weekly basis.


