In partial modification to Fisheries order No. 39 of 2021 Dated 25-02-2021, Sanction is hereby accorded to the withdrawal of 03 Nos. of LCHs under General Category from District Bandipora and their subsequent allotment in favour of District Jammu District. The revised allocation of financial/physical targets alongwith withdrawal/allotment of funds as **Central Share under the Centrally Sponsored Scheme "PMMSY"** Scheme for Construction of Low Cost Houses under **General Category/SC/ST** is detailed below. The scheme should be implemented strictly as per norms & guidelines of the Ministry of Fisheries, Animal Husbandary & Dairyng, Department of Fisheries and instructions issued by the J&K Government from time to time. The concerned Joint Directors shall monitor the implementation of the scheme on weekly basis.

- d Monthly/quarterly progress reports indicating physical/financial achievements should be submitted to this office by or before 5th day of every next month/quarter positively.
- e Release of funds in no case is an authority to draw the payments from the treasury unless & until DDO will fully satisfied about the genuinity of claim.
- f The account officer shall vouchsafe the utilization of funds as per codal formalities /GOI guidelines.
- g No deviation in specification shall be entilled for payment except those approved by the competent authority
- h The expenditure shall be booked strictly on the approved components of the scheme.
- i Joint Director Territorial Jammu/Kashmir will furnish the soft/hard copy of the consolidated list of beneficiaries selected for providing assistance beside ensuring the beneficiary share as well.
- j The scheme shall be implemented as per the guidelines & in the approved sharing pattern as provided in the scheme for the construction of Low Cost Houses (Housing for Fishers).
- k The concerned Joint Director/DDO shall submit the utilization certificate of funds released as soon as they are utilized and definitely well before 31.03.2020 as per the format GFR 12-C
