A sum of ₹ **1,39,500/-** out of aggregating amount of ₹ **3,43,500/-** sanctioned in **07/2020** is still outstanding against the subscriber. Fresh advance of ₹ **1,30,000/-** together with previous balance of ₹ **1,39,500/-** aggregating to ₹ **2,69,500/- (Rupees two lac sixty nine thousand and five hundred only)** shall be recovered in **45** equal monthly instalments of **Rs 6000/-** and last being of **Rs 5500/-** Commencing from the salary of the month following the month of drawal of the advance.
