Sanction is hereby accorded to the release of funds amounting to Rs 452.5925 lacs through PFMS mode as Central Share under the Centrally Sponsored Scheme "PMMSY" 2022-23 (2<sup>nd</sup> installment) in favour of the Districts as detailed in Annexure "A". The scheme should be implemented strictly as per norms & guidelines of the Ministry of Fisheries, Animal Husbandry & Dairying, Department of Fisheries and instructions issued by the J&K Government from time to time. The concerned Joint Directors shall monitor the implementation of the scheme on weekly basis.

**The Allotment is subject to the fulfillment of the following conditions**

1. Detailed operational Guidelines of the PMMSY and other concerned stockholders. Implementation of the above said approved activity of is governed by the relevant provisions of the operational Guidelines of PMMSY.
2. The DDOs will ensure utilization of the central funds strictly as per the Terms and Conditions (T&C) of the sanction and for the purpose for which it is released.
3. No diversion of central funds for any other purpose shall be allowed. In case, the DDO fails to utilize the sanctioned central funds under PMMSY, they shall return the same along with accrued interest thereon, if any.
4. The DDOs shall maintain and preserve proper record on the expenditure incurred on implementation of the approved activity, produce the same as and when desired by the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying, Government of India and audit, both by the Comptroller and Auditor General of India and Internal Audit of the concerned Principal Accounts Offices, Government of India.

5. No deviation in the approved activity shall be permitted without the prior approval of the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying. In case, the approved Livelihood activity needs to be revised with any addition/deletion/modification on account of any unavoidable circumstances, then the concerned State/UT shall obtain prior approval of Director of Fisheries for such revisions.
6. The DDOs shall complete release of Livelihood support to the enrolled beneficiaries as approved under the Livelihood activity of PMMSY during the current financial year (2021-22). The concerned State/Ut will also ensure release/utilization of beneficiary contribution.
7. The DDOs shall regularly submit physical and financial progress reports on implementation of the approved Livelihood activity on a quarterly basis until completion of the release of Governmental assistance. The progress reports shall be submitted to the Department of Fisheries,
8. The DDOs will ensure transfer of benefits to the beneficiaries through Direct Beneficiary Transfer (DBT) platform in to their Bank accounts through electronic, mobile number, and account number to the Department of Fisheries as well as NFDB.
9. The DDOs will ensure that the expenditure incurred on implementation of the approved Livelihood activity is strictly in accordance with the provisions of PMMSY and also GFR 2017.
10. The DDOs will submit the MPR under the scheme before 2<sup>nd</sup> day of every month along with DBT information.
