A sum of ₹ 6,66,940/- out of aggregating amount of ₹ 9,04,600/- sanctioned in 05/2022 is still outstanding against the subscriber. Fresh advance of ₹ 4,20,000/- together with previous balance of ₹ 6,66,940/- aggregating to ₹ 10,86,940/- (Rupees ten lac eighty six thousand nine hundred and forty only) shall be recovered in 60 equal monthly instalments of Rs 18116/- and last being of Rs 18096/- Commencing from the salary of the month following the month of drawal of the advance.
