3. That the incumbents were not under suspension or contemplated on any charge of charge-sheet under Classification Control and Appeal Rules 1956 or any other rules and their work and behavior have remained satisfactory.
4. That the present In-situ promotion shall not change/effect the existing designation/ seniority/duty.
5. That the benefit of HSPS shall not be given to such of the employees who had relinquished/forgone the functional promotion for any reason, whatsoever.
