A sum of ₹ 2,28,936/- out of aggregating amount of ₹ 4,30,000/- sanctioned in 04/2021 is still outstanding against the subscriber. Fresh advance of ₹ 3,96,000/- together with previous balance of ₹ 2,28,936/- aggregating to ₹ 6,24,936/- (Rupees six lac twenty four thousand nine hundred and thirty six only) shall be recovered in 60 equal monthly instalments of Rs 10500/- and last being of Rs 5436/- Commencing from the salary of the month following the month of drawal of the advance.

The official is not likely to retire before the liquidation of advance in full as the date of birth of the official is 01-11-1977 and the advance is within 75% of available balance so computed.
