Pursuant to the approval conveyed by General Administration Department vide above referred Office Memorandum, sanction is hereby accorded to the temporary appointment of Smt. Smt. Rukeena Akhter Wd/O Late Tanveer Ahmad Sofi (Ex-Fisheries Guard) R/O Kakapora, Pulwama presently at Dangerpora, Noorpora Tral Pulwama on Compassionate grounds as Multitasking Staff (Class-IV) District Cadre Pulwama in the Pay Level SL-1(14800-47100) against an available post in the Fisheries Department in relaxation of rules viz qualification as notified by General Administration Department vide OM No. GAD-SRO/209/2024 (7447708) dated 22.05.2024.

The appointee shall report to the office of Assistant Directorate Fisheries, District Pulwama within a period of (21) days from the date of issuance of this order and shall be allowed to join only on the production of following documents/certificates in original to be verified subsequently by the concerned Assistant Director.


- i. Academic Qualification certificate.
- ii. Date of Birth Certificate.
- iii. Domicile certificate.
- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- v. Dependent certificate issued by the Assistant Commissioner Revenue.
- vi. No loan certificate under self-employment scheme from DIC concerned and employment Department.
- vii. All other relevant documents as required under SRO-43 of 1994.

The appointment of the appointee shall further be subject to the following conditions:-

- a. That the appointee shall submit an undertaking duly attested by 1st Class Magistrate to the effect, *that if, on verification, genuineness of the qualification Certificate/s and other documents from the concerned issuing authority is/are found fake/forged, the claim of the appointee for appointment as Class-IV*

(MTS) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.

- b. The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of all the documents as mentioned above is received in her favour.
- c. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- d. That if the appointee has taken loan for self-employment from DIC Employment Department to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of her Domicile District, the appointee shall be required to repay the entire loan facility in suitable EMIs to be worked out by the DDO concerned from her salary. The appointee shall also relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. DDO Concerned shall obtain an affidavit, duly attested by First Class Magistrate, from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- e. If the appointee fails to join within a period of 21 days from the date of issuance of this order, she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
