

- Funds shall be utilized for execution of the scheme strictly as per originally approved components and according to Govt. of India's prescribed guidelines and there shall be no diversion of funds.
- The concerned JDs / DDOs shall send utilization certificate of the funds released as soon as the funds are utilized and definitely well before 31.03.2019.
- Drawing and Disbursing officer shall ensure that funds released are utilized prudently and judiciously and in no case they should book the exp. Just for the sake of spending; DDO shall complete all codal formalities before presentation of bills in the treasury.

- iv. The exp. Shall be made strictly as according to classification under which funds have been authorized by Finance Department.
- v. Treasury officers shall not allow parking or drawal of funds in the Civil Deposit without prior concurrence of the Finance Department in corordination with Adminstrative Department..
- vi. Treasury Officers shall not entertain bill without complete classification under which funds have been authorized by Finance Department.
- vii. Monthly/quarterly progress reports indicating physical/financial achievements should be submitted to this office by or before 5th day of every next month/quarter positively.
- viii The Concerned JDs / DDOs shall ensure that there is no overlapping /duplication in adoption of scheme/incurring of exp. From any other scheme of State or Central Government.
- ix. The concerned DDOs shall implement the programme/work aiter accord of Adminstrative approval/Technical sanction, wherever required by the competent authority, and all sanctions, approvals, clearance shall be in place before drawal of money from treasury.
