**RATE CONTRACT**

**Subject: - Fixation of Annual Contract for Supply of Linseed Oil required for manufacturing of Trout Fish Feed.**


**Reference: - This office e-Tender Notice No:-02 of 2018 Dated:- 18.09.2018.**

The State Level Departmental Purchase Committee conducted meeting on 26.10.2018 under the chairmanship of Director Fisheries, interalia has accepted the lowest rate offered by M/S Gangamata Jal Ghar Chalkdighi More, Memari(Choumatha) Burdwan, West Bangal in respect of Linseed Oil and approved fixation of annual rate contract for the year 2018-19 with the agency on the terms and conditions mentioned below. The Chief Project officer Kokernag/Senior Project officer Trout Fish Feed Mill Manasbal is directed to receive the material/utilize the supplies and release the payment after fulfilment of all below mentioned condition in letter and spirit.

**The supply shall be governed by the following terms and conditions:-**

1. The material shall be strictly of Standard quality. In case any sub standard material is supplied the same shall be rejected at the cost and risk of the supplier. The supplier shall replace the same with the material of required specification and in case of his failure same shall be arranged from alternate sources at the cost of supplier. The supplier shall be bound to lift such sub standard supplies immediately from the stores of the Project.
2. The material shall be received in presence of a team of officers to be nominated by the Joint Director Fisheries Kashmir (Projects).
3. Challan of the transport company in original should be provided, without which no payment shall be released by the authority.
4. The Chief Project officer Kokernag/Senior Project officer Trout Fish Feed Mill Manasbal shall ensure receipt/verification of material in presence of the nominated committee. Payment shall be released to the agency only after receipt/verification, final testing and acceptance of supplies (at destination i.e. Kokernag/Mansabal Kashmir) from the committee and its proper entry in relevant stock registers.
5. The Chief Project officer Kokernag and Senior Project officer Trout Fish Feed Mill Manasbal will be wholly and solely responsible for quality control of the supplies.



6. The supply order for the quantity of the materials required from time to time shall be placed/issued by Chief Project officer Kokernag and Senior Project officer Trout Fish Feed Mill Manasbal who shall have their requirement approved from Director Fisheries J&K Government in the first instance.
7. The rate mentioned above are FOR stores of Chief Project officer Kokernag/ Senior Project officer Trout Fish Feed Mill Manasbal and shall include all taxes/duties/CGST/SGST, transportation carriage and other incidental.
8. This rate contract shall be valid for one year from the date of issuance of this Rate Contract.
9. This rate contract shall be subject to terms and conditions mentioned in the tender document of e-tender Notice No. 02 of 2018 dated 18.09.2018.
10. The approximate quantity indicated above are on the basis of demand projected by the Chief Project Officer, Kokernag & Senior Project Officer, Manasbal. The supplies should be made strictly as per the supply orders to be issued by the Chief Project Officer, Kokernag and Senior Project Officer Trout Fish Feed Mill, Manasbal duly approved by Director Fisheries.
11. **Statutory deduction @ 2% on account of GST supposed to be deducted at source by the DDO, implemented vide SRO 433 dated 29-09-2018 w.e.f. 01-10-2018 shall be deducted from each supply, as rate contract exceeds 2.5 lacs.**
