The Trout Fishing permits will be available for esteemed foreign Anglers throughout the week and for local esteemed anglers it is will be available for Saturday, Sunday, Tuesday and Thrusday (04 days in a week). The Trout beats for fishing will be allotted on first come first serve basis. Few beats shall remain reserved/restricted for conservation purposes. The Esteemed Anglers are requested to co-operate with the Department for ensuing judicious trout angling in all the streams and book the permits as per the availability
