Sub: Issuance of Trout Angling permits during the year 2022

The Angling season of Trout fish in the trout streams of Kashmir Valley has already set in. The booking of trout angling permits had been made through on-line mode on the portal developed by C-dac but during the previous years this Directorate received lot of grievances from the Esteemed Anglers (both local as well as foreigners) that the site is not working properly and they face lot of difficulties during the booking of Trout permit through on-line mode. Now the Department has decided to make/develop a new **Mobile App** for booking of Trout permits through on-line mode in a very easy way. Since the Mobile App is under process and it will take another 15 days to complete it, so the Department of Fisheries shall issue the permits through Off-line mode from Directorate of Fisheries J&K at Tourist Reception Centre (Dalgate) Srinagar on first come first serve basis on all days upto 02.00 PM. The Trout Fishing permits will be available for esteemed foreign Anglers throughout the week and for local esteemed anglers it is will be available for **Saturday, Sunday, Tuesday and Thursday (04 days in a week)**. The Trout beats for fishing will be allotted on first come first serve basis. Few beats shall remain reserved/restricted for conservation purposes. The Esteemed Anglers are requested to co-operate with the Department for ensuing judicious trout angling in all the streams and book the permits as per the availability

Esteems Anglers are requested to co-operate for strengthening of long prosperous world class Trout Angling in Kashmir in particular.

Wishing all esteemed Anglers good and thrillful fishing in forthcoming fishing season.
