Consequent upon poor response from the aspirants under SC and ST categories applications are re-invited from unemployed youth/interested persons of the UT of Jammu and Kashmir who intend to adopt Trout and Carp Fish Culture under "Pradhan Mantri Matsya Sampada Yojana" (PMMSY) during the year 2022-23.

The applications shall be invariably submitted in the respective offices of Assistant Director Fisheries of the concerned District upto 27th January 2023.

Terms & Conditions:

1. The intended beneficiary should be in possession of land facility where 50 cu.mt rearing space can be created with allied structures of watch and ward, feed/equipment store and in case of Carp Fish pond 03 Kanals of land should be available
2. The intended land should be a proprietary land free of mortgages and other encumbrances.
3. The intended land should have a suitable gradient for Fish culture.
4. The water source, to be utilized for the Trout culture should be perennial in nature, preferably spring source, having suitable physio-chemical parameters particularly Temperature and Dissolved Oxygen Content.
5. The short listing of the sites in respect of feasibility should be carried out by the District Level Committee keeping in view the Mapping and subsequent climatic conditions of the area.

6. The Final Selection of the intended sites shall be the domain of District Level Committee framed vide Govt. Order No. 944-JK(GAD) of 2020 dated:15-10-2020 and shall be guided by the necessary orders/guidelines/clarifications issued in this regard from time to time& subject to the availability of funds under the scheme.


