# Order No: 31 -Fisheries of 2024

## DATED: 09 -01-2024

WHEREAS, the Government vide Order No 141-JK(ASH) of 2021 dated: 05.10.2021, issued the final seniority list of Inspector Fisheries/eqvl category of the Fisheries Department as it stood on 01.01.2008 and 01.01.2010 respectively for information of all the members of the service. and;

WHEREAS, the Government regularized the services of some Inspector Fisheries/eqvl. as Fisheries Development Officer/Project Officers on the basis of above final seniority list vide Government Order No; 114-JK APD) of 2022 dated: 15-07-2022 and;

WHEREAS, consequent upon this, it was deemed necessary and expedient to update the seniority list of Inspector Fisheries/eqvl categories, and;

WHEREAS, the Department issued the tentative seniority lists of Inspector Fisheries/eqvl vide Notification No 01 of 2023 dated: 01.05.2023 & 02 of 2023 dated; 14.07.2023 respectively, as it stood on 01.01.2016 inviting objections from all the concerned within a stipulated period of 21 days along with supporting documents, if any, regarding their claim and;

WHEREAS, in response to the tentative seniority lists, (Supra), the Department received various representations from the officials and the Department examined all the representations and deemed its necessary to place all these representations before the Departmental Promotion

Committee for their judicious examination/consideration and recommendations if any, thereof, in this regard. and;

WHEREAS, the Departmental Promotion Committee in its wisdom examined all the representations during which it was observed that in majority of cases, the officials had agitated the settled matters which are time barred and as such not worth for examination / consideration by the DPC in view of the Government instructions and the law laid down by the Hon'ble Supreme Court in this regard. and;

WHEREAS, the DPC submitted its recommendations on 14.12.2023 in this regard, while conveying its recommendations suggestions/ advice, the DPC desired that before finalizing the final seniority list of the category, a fresh tentative seniority list be prepared and notified for information of all the members of the service for inviting objections, if any, within a period of seven days, and;

WHEREAS, on the basis of recommendations / advice of DPC, fresh tentative seniority list of Inspector Fisheries/eqvl. of J&K Fisheries Department was issued by the Department vide Notification No 03 of 2023 dated:18-12-2023 inviting objections, if any, within seven days from all the concerned. The notification was published in the leading newspapers to ensure wide publicity and also uploaded on the Departmental website www.jkfisheries.in, and;

WHEREAS, in response to the fresh tentative seniority list, the Department received some representations which were examined on the basis of the available records, Rule position, quota between Direct Recruiters / Promotion and other facts and it was observed that all these representations were mostly repetition of previous representations submitted by these officials which stood examined /decided by Govt as well as DPC and mainly resting their claim on restoring of the seniority list issued earlier by the Department though same were quashed by Hon'ble High Court, J&K and also nullified by the Government while issuing the final seniority list of Inspector Fisheries/eqvl. vide Government No141-JK(ASH) of 2021 dated: 05.10.2021 (Supra) and none of the officials of the category challenged the said final seniority list issued by the Government at the relevant point of time.

WHEREAS, the said final seniority list issued by the Government was acted upon by the PSC/DPC while regularizing senior most Inspector Fisheries as Fisheries Development Officer/ Project Officer. Hence, all these representations were disposed of accordingly on merits. and;

**Now therefore**, the Final Seniority list of Inspector Fisheries/equivalent category of Fisheries Department, J&K, restricted to the total sanctioned cadre strength of 59 posts (30: 29) between Direct and Promotion Quota as it stood on 01.01.2016 forming Annexure "A" to this order is issued for information of all the members of the service.

The Date of birth and qualification indicated against the officials in the final seniority list shall be subject to verification / authentication as and when deemed necessary.

This issues without prejudice to the outcome of the writ petitions(s) pending, if any, before any competent court of law of UT of J&K.
