The successful tenderer shall in no case sublet his contract for supplies to any person or agency.

- 6. The supplier shall have valid TAN/GST registration proof of having filled returns of income Tax/GST for the last three years. Reasonable and fair turnover of the supplier for the last three years with respect to volume/estimate cost of the goods.
- 7. The rates offered shall be inclusive of all taxes, duties, GST, carriage or any other incidental charges etc. and the same shall be FOR stores of Chief Project officer Trout Fish Farming Project Kokernag as well as Manasbal Kashmir. - 12. The department shall not be bound to issue supply order for full advertised quantity at one time and the same shall depend on availability of funds and requirement of the department. However, since the drugs/medicine/Chemicals are required for sensitive live stocks as such supplier is are bound to supply as much quantity of materials so that at least requirement for three months always remains in the stores of Chief Project officer Kokernag and Senior Project Officer Trout Fish Feed Mill Manasbal.
- 13. The supplies shall be of standard quality strictly as per specifications mentioned in supply order free from adulterations/defects of any sort. In case materials are found below standard or defective, same shall be rejected at the risk and cost of supplier. For this purpose, the department shall frame inspection/verification committee which will ascertain the quality of materials and also verify quantity supplied by the supplier before taking such materials on books.
- 14. The product should be supplied in company's original packing having proper batch no/date, date of manufacture. Shelf life for each item should be more than one year from the date of placement of supply order or receipt of supplies whichever is later.
- 15. The vitamins should be preferably in small packing of 2 kg each.
- 16. Any batch of Drugs/medicines/Chemicals supplied shall be subject to random testing through Govt/Private Laboratory at the discretion of Survey/Inspection Committee.
- 17. The ordered quantity shall have to be supplied within 25 days from the date of issuance of supply order by the Department. Supplier is required to remain in touch with the Chief Project officer Trout Fish Farming Project Kokernag viz a viz Senior Project Officer Trout Fish Feed Mill Manasbal to ascertain their requirement of various items from time to time.
